**Keywords:** immediately after the abstract, provide a maximum of 5 keywords, avoiding plural terms, multiple concepts as well as "and", "of".

**1. INTRODUCTION**


Provide the objectives of the work and an adequate background, avoiding a detailed literature survey or a summary of the results. The first paragraph should be written with no indent. All cited papers, i.e. (Surname1, 2000a), (Surname1, 2000b), (Surname3 and Surname4, 2002), and Surname3 et al. (2003) should appear in alphabetic order, by the surname of the first author. Please ensure that every reference cited in the text is also present in the reference list.

The second paragraph as well as the next ones should have no indent. Subsequent paragraphs should be separated by a vertical space of 6 pt. The font used in the text is Times New Roman, size 12 pt., with leading equal to 1 pt. Headline parameters for sections: bold, uppercase letters, 12 pt.; for subsections: bold, 12 pt., for subsubsections: italics, 12 pt. In each level the heading is separated by a break 12 pt. before and 6 pt. after.

**2. NEXT SECTION**

The first paragraph should be written with no indent. Please write your text in good English (American or British usage is accepted, but not a mixture of them), do not use hyphenation. Figures and tables should follow caption. The captions of the figures should follow the figures and the titles of the tables should come before the tables. Figure 1 presents the cover of the Artificial Satellites, Journal of Planetary Geodesy. The figure and table captions should be in font 11 pt. with the word "Figure"/"Table" and the number in bold.

### 3. SECTION WITH SUBSECTIONS

In the case of a well-developed article structure, subsections should be used to preserve readability.

#### 3.1. First subsection

Multilevel numbering should precede the title of each subsequent subsection.

Equations should be placed within the text (1). They should be centered and numbered successively with Arabic numerals (minor non-referenced expressions might be not numbered). The equation's number should be positioned in parentheses right justified at the line of the equation:

$$\alpha = \sqrt{\beta} \quad (1)$$

where:

- $\alpha$  – first variable description;
- $\beta$  – second variable description.

#### 3.2. Second subsection

If you use the Microsoft Word template, you should use the appropriate styles defined in the document. Use the "text" style for the article content and references as well. Similarly, for figure and table captions use "figure" and "table" style, respectively.

If the next level is necessary – the next level can be used.

### 3.2.2. Second subsection

Consistently use multi-level numbering.

## 3. CONCLUSIONS

Each contribution submitted to publication in our Journal should have original conclusions and, like in the introduction, the first paragraph should be written with no indent.
